I am directed to intimate that this office has received approval from the Administrative Department vide communication No. Edu-GEN/611/2024-01-(7593888) dated 04.07.2025 regarding the deployment of Subject Specific Teachers by issuing orders afresh, engaged under the erstwhile RMSA Scheme.

Accordingly, this office has issued a communication vide letter No. Edu/PD/Sms/Esstt/2841-47/2025-26 dated 22.07.2025 to your offices for furnishing the verified list of subject-specific teachers, and in response to our communication, a verified list of Subject Specific Teachers has been received vide your letter No. DSEJ/NG/Tr/40849-51 dated 26.07.2025 and DSEK/Estt.111/ B.Trs/Misc/18/025/2178-89 dated 29.07.2025,

In view of the above, it is requested that **necessary instructions** may kindly be issued to the **concerned Chief Education Officers (CEOs)** of your respective divisions to **engage these Subject Specific Teachers for the districts where they were deployed earlier for the current academic session 2025-26**, purely based on the requirement in upgraded Government High Schools in the respective **districts after due screening as directed by the Government.**

Further, it is also requested that after deployment of these subject-specific teachers, **if a vacancy arises**, then respective CEOs may proceed for engagement of subject-specific teachers on the analogy of the procedure adopted in case of CRCs, as already sanctioned by the **Government.**



In this regard, it is clarified that the current deployment of subject-specific teachers shall be governed by the following terms and conditions:

1. The engagement shall be purely on term contract basis for the academic session 2025-26. The contract shall be liable for immediate termination with one-month prior notice or one month's salary in lieu of notice, in case of performance falling below the acceptable standard.
2. The Subject Specific teachers shall be required to teach classes at any level, as per the needs of the school.
3. Ordinarily, the candidate shall be posted within the home district as per earlier orders of RMSA. However, if required, the candidate may be posted anywhere in the UT of J&K. Refusal to serve at the designated place of engagement will result in immediate termination.
4. At the time of engagement, the deployed candidates will be required to sign an agreement containing terms & conditions as prescribed by Samagra Shiksha, J&K on an affidavit duly attested by a Judicial Magistrate, 1st class. They shall also submit an undertaking on the affidavit that he/she will not claim any entitlement for absorption in Govt. service or in the Chirag society at any stage of their engagement with the society or thereafter at the closure of the project, and that he/she is ready to serve in any part of the UT of J&K.
5. The concerned Drawing and Disbursing Officers (DDOs) shall ensure that no honorarium shall be drawn or disbursed to the subject-specific teachers until a valid Character/Antecedent Certificate is produced by the concerned teacher, duly issued by the local police.
6. The engagement of the subject-specific teachers shall be subject to the outcome of any writ petition(s) if any are pending in any court of the competent jurisdiction.
7. The whole process shall be completed under overall supervision of SPD SAMAGRA in consultation DSEJ/K within 30 days of issuance of this letter.

This issues with the approval of competent authority.


